Winter Programs

Wasatch Adaptive Sports' provided 1,215 instructional lessons in skiing, snowboarding, and indoor cycling to 273 students with adaptive needs representing a 32% increase in individuals served over the prior year. An additional 79 individuals within the students' support network participated in 389 lessons. In the survey disseminated to those students who participated in the 2018-19 winter programs, respondents reported improvements in overall mental health (92% of respondents), independence (90%), quality of life (96%), and motivation to be active (96%) as a result of program engagement.
